GENERAL MEMBERSHIP MEETING  
August 26, 2009**

**Call to Order:**

Genie Short opened the meeting at 1:07pm.

**Secretary:** The June 24, 2009 minutes were read with no corrections. Darlene Lewis motioned to approve, seconded by Jack Feinberg, unanimously approved and carried.

**Presentation-** Eva Kimonis, PhD is an Assistant Professor at the University of South Florida. She spoke about her research on secondary psychopathy, a risk factor for substance abuse and violence in juvenile offenders. A subtype of youth psychopathy conduct disorder includes the development of Callous/Unemotional (CU) traits which can lead to psychopathy in adulthood. CU youth display anti-social and aggressive behavior and can be treated with intervention that involves multi-systemic therapy. The Paul Frick scale can be used to identify CU traits.

**Grants/Fundraising** – Genie Short reported that she is waiting for status of her applications for the Juvenile Crime and Violence and Drug Free Communities (DFC) grants. The SARG/TAC/PPG grant was approved and Jack Feinberg/Phoenix House is the parent navigator for the grant.

**Marketing/PR** – Genie Short reported that they are working on billboards for the PPG grant as well as movie theatre marketing for tobacco prevention. Invitations and sponsor information are being put together for the upcoming fundraiser on November 12-13, 2009.

**Prevention/Education** – Regina Birrenkott reported that information about the Too Good for Drugs Walk/Banner Contest/Kid Fest on October 3, 2009 has been distributed to the schools.

**Public Policy/PDM Bill** – See New Business for Report on National Drug Czar meeting.

**Tampa Alcohol Coalition** – Ellen Snelling said she would like HCADA/TAC to send a sympathy letter to Major McNamara for Corporal Roberts of TPD who was recently killed on duty. Ellen, Sue Carrigan and Deputy Scott Sitton attended the Underage Drinking Conference in Dallas, Texas for the SARG grant. Lisa Hilko is the new SARG Coordinator. The new phase of the grant involves a focus on juvenile violence with substance abuse and alcohol. Ellen may need data. An advanced marketing class at USF is working with TAC to help with marketing and focus group efforts. Ellen advised of an upcoming hearing of the Public Transportation Committee about HOP Tampa, a safe ride company. They recently had to cease operations in downtown Tampa due to safety and permitting concerns. They provide a good service and Ellen hopes they can resolve any issues and get back in business. The Recipes for the Road book contains alcohol-free drinks for designated and safe drivers. This year's book is in production and they are looking for restaurants to contribute recipes. The next TAC meeting is to be held on September 15, 2009 at TPD District 2 at 3:00pm. A DUI offender is to speak.

**SWAT** – Laurie Ellston reported that two orientations were held the week of August 17, 2009 to educate resource officers about tobacco citations before they go into the schools. The Tobacco-Free Florida is to be at Kid Fest with a van that can take a picture and age it 10 years to show the affects of tobacco and smoking. On October 23, 2009 Laurie is to present a plaque to Judge Nazaretian for his outstanding work with tobacco offenders.

**New Business**

Kid Fest – Sue Carrigan announced that Kid Fest is to take place at MOSI on October 3, 2009. The Too Good for Drugs Walk is to begin at 9:30am.

Report on Meeting with National Drug Czar – Helen Justice/DUI Counterattack attended this meeting on behalf of HCADA. Topics discussed were issues that caused Florida to take so long (FL is the 39<sup>th</sup> state) to enact a Prescription Drug Monitoring Program (PDMP) such as “big brother” and the “hacking incident” that caused concerns about confidentiality and violations of privacy. FMA endorsed the bill which made a major impact. Concerns exist regarding 15-day reporting versus “real time” reporting. The ECASPER system has a 15-minute reporting delay. Kentucky’s system is the nation’s model. Funding issues were discussed as there are no NASPER funds available. There is funding available for Harold Rodgers prescription drug monitoring. An assessment fee for PDMP users is to be considered. PMIX in Ohio is involved in a pilot study as a host agency with Kentucky and Nevada. Results are to follow. Several attendees such as Dr. Laura Brown, a Pain Management Physician and Pepper Wakeland, a pharmacist and Sarasota PDMP Task Force member, offered their support to HCADA’s PDA Task Force.

National Recovery Month – Claire Feagley/BayCare Behavioral Health informed members of their Rockin’ Recovery event to be held on September 26, 2009. Sponsorship opportunities are available. They are also offering tickets for the Tampa Bay Rays vs. New York Yankees game on October 2, 2009. A portion of the proceeds will go to support National Recovery month. Baycare is also to present Bob Holm with an award at their Children’s Outpatient Services Open House event on August 28, 2009.

USF – Jennifer Fuller announced their new Vice President of Wellness is to create a statewide committee on alcohol that would go to legislators and help change alcohol laws.
